Viridian Harvest Home Tour Event Official Rules

MUST REGISTER BY VISITING A PARTICIPATING MODEL HOME. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The "Viridian Harvest Home Tour" begins at 12:00:01 a.m., Central Daylight Time ("CDT") on September 1, 2024 ("Contest Start Date") and ends at 11:59:59 p.m. CDT on November 10, 2024 ("Contest Period"). Contest is sponsored by Viridian Holdings, LP, 2201 E. Lamar Blvd., #115 Arlington, TX 76005 (the "Sponsor"), who is solely responsible for all aspects of this Contest.

Eligibility: Contest is open to all legal residents of the United States and District of Columbia who are 21 years of age or older as of the Contest Start Date.
